



NT KENO 2010 Cruizin Cooler Promotion Terms and Conditions

1. The NT Keno 2010 Cruizin Cooler promotion will be held as follows:
 - 1) SKYCITY Darwin will hold this promotion between 10:00am on Friday 28 May 2010 until 5:00pm on Friday 16 July 2010,
 - 2) All remaining NT Keno venues will hold this promotion between 10:00am on Friday 25 June until 5:00pm on Friday 16 July 2010.
2. Prize draws will take place at all Operating NT Keno venues on Friday 16th July 2010.
3. All Operating NT Keno venues will participate in the promotion.
4. Each venue will be provided with promotional material to be placed near the NT Keno terminal and throughout their venue.
5. Each venue is responsible for ensuring compliance with the terms and conditions of the promotion.
6. The following are ineligible to enter the NT Keno 2010 Cruizin Cooler promotion
 - Persons under the age of 18 years
 - Employees of SKYCITY of any capacity
 - NT Keno Operators and NT Keno Senior Operators
 - Any person who at the time of the promotion is excluded under the relevant provisions of the Northern Territory Gaming Legislation
7. There will be one prize winner per venue.
8. Entry into the Draw

A person is entitled to one entry, at the time of entering an NT Keno game. One entry ticket will be provided for every single ticket purchased to the value of \$10 or more on NT Keno.
9. The customer display on the NT Keno terminal will advise the customer that they have been issued a ticket in the Major draw. The ticket will contain the words 'SPECIAL PROMOTION TICKET' printed on it, with provision for the customer to include their name address and phone number.
10. To be eligible to participate in the NT Keno 2010 Cruizin Cooler promotion prize draw, persons must correctly complete a valid entry ticket and place it in the entry box at any NT Keno venue.
11. Persons must include their name, address and telephone number on the entry ticket for the ticket to ensure adequate identification and validity of the ticket.
12. NT Keno cannot accept responsibility for invalid entries.
13. Entry tickets may be placed in the designated entry box at any NT Keno venue until 5.00pm on Friday 16 July 2010.

14. Prize Draw
- i The prize draw will take place at each participating NT Keno venue on Friday 16 July 2010, via a barrel draw.
 - ii The time of the barrel draw will be at the discretion of each venue manager but must take place on Friday 16 July 2010.
 - iii Each participating NT Keno Venue will be responsible for contacting the entrant identified on the first valid entry ticket drawn, by the telephone number identified on the entry ticket.
 - iv If the entrant is unable to be contacted by 12:00pm on Friday 23 July 2010 the prize will be forfeit and a redraw will occur on this day.
 - v The redraw entrant must contact the venue within 48 hours of the redraw.
 - vi Redraws will continue until Friday 30th July 2010 until an eligible winner claims the prize.
 - vii Suitable identification may be sought from the person who presents themselves as the winner of the draw.
15. The Prize
There will be one prize for participating NT Keno venues of Cruizin Cooler valued at \$400 each.
16. Each venue is responsible for the loss or damage of their prize.
17. Prize not redeemable for cash.
18. Management's decision is final and no correspondence will be entered into.

NT Keno/SKYCITY Darwin shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of taking any of the prizes, except for any liability which cannot be excluded by law.

 - Each venue will be provided with promotional material to be placed near the NT Keno terminal and throughout their venue and are responsible for ensuring compliance with the above conditions.
